Flat Fee: Accommodation costs and daily allowance	
Accommodation costs including daily allowance Day 1 till day 14 of your stay	90 €/day (day 1 till day 14)
Accommodation costs including daily allowance Day 14 till day 30 of your stay	60 €/day (day 11 till day 28/29/30/31)
Accommodation costs including daily allowance Month 2 and onwards	1.200 €/month or 40 €/day
